4. First-aid measures

If swallowed, irritation, any type of overexposure or symptoms of overexposure occur during use of the product or persists after use, immediately contact a POISON CENTER, an EMERGENCY ROOM or a PHYSICIAN; ensure that the product safety data sheet is available.

6. Accidental release measures

Personal precautions: No action shall be taken involving any personal risk or if you do not have suitable training or protection. Evacuate surrounding areas. Do not touch or walk through spilled material. Shut off all heating and ignition sources. Avoid breathing vapor or mist. Provide adequate ventilation. Methods and materials for containment and cleaning up: Stop leak if without risk. Move containers from spill area. Contain leaks and pick up with non-combustible absorbent materials such as sand, earth or vermiculite. Then, place in an appropriate waste disposal container according to local regulations. Dispose of via a licensed waste disposal contractor.

7. Handling and storage

Precautions for safe handling: Put on appropriate personal protective equipment (see Section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Avoid exposure - obtain special instructions before use. Avoid contact with eyes, skin and clothing. Do not ingest.
