### 4. First-aid measures

### 6. Accidental release measures

**Personal precautions:** No action shall be taken involving any personal risk or if you do not have suitable training or protection. Evacuate surrounding areas. ### 7. Handling and storage

Conditions for safe storage: Store in accordance with local regulations. Store in a segregated and approved area. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
